REPORT OF THE LIBRARIAN

Library Director Osuch reported on Summer Reading programs, discussed plans for new shelving in the kids' zone, shared a special Olympia Fields Update prepared by Katherine Henderson, and distributed packets of sunflower seeds.

The Trustees inquired if a non-resident fee could be charged so that teens from Olympia Fields might be able to participate in the Teen Zone summer camp. Library Director Osuch will inquire with the Park Forest Recreation and Parks Department, since they are sponsoring the program. The Trustees will also reach out to the Village of Olympia Fields and the Parks Department to increase future partnership opportunities and youth initiatives. Village Trustee Nale requested that Library Director Osuch email a formal request to her that she can forward to the Village Board regarding sharing Library information and updates with the Village.

The Trustees asked that the phrase, "Serving the communities of Park Forest and Olympia Fields," be placed on all flyers and brochures. They also asked if this could be included inside the Library near the entrance.

Trustee Nale visited the Library recently to renew her library card, and she commended the collections and services and complimented the friendly staff.

Trustee Braden inquired about Friends of the Library leadership and revival.
